Opportunity

A mixed use development opportunity with the potential for an investor to work with the existing joint venture partnership across investment opportunities consisting of digital studio, office, residential, retail and leisure. Over 140,000 sq metres of floor space has been constructed to date, with future phases taking the total floor area to c. 160,000 sq metres.

Current investment opportunities exist in; residential, retail, leisure and office, with a total forward funding commitment opportunity totalling £330 million spread across 3 distinct development plots.

Overview

Background

MediaCityUK is home to the BBC, ITV, dock10, the University of Salford, Ericsson, Kellogg's and more than 250 smaller creative and digital businesses. Located on the banks of the Manchester ship canal, MediaCityUK has been designed with a focus on the creative, media and digital sectors and the next generation of digital entrepreneurs.

Providing high levels of power and connectivity resilience the community features one of the biggest HD studio complexes in Europe and is complemented by nearly 400 apartments, two hotels and a distinctive range of bars and restaurants. More than 7,500 people work, live and study here. Plans for phase two were approved in September 2016 and will see MediaCityUK double in size over the next decade. MediaCityUK is a joint venture between Peel Media and Legal & General Capital.

Project Description

The vision is for MediaCityUK to become a leading international hub for the creative and digital sectors - and a vibrant destination to work, live and play. Manchester has always shone on a global stage and MediaCityUK is no exception. In seven years, a derelict port has been transformed into a creative portal and it is now a waterfront destination, with digital creativity and learning at its heart.

Phase 2 of this bespoke community consists of 925 new apartments, 35,000 sq metres of commercial floor space, 3,200 sq metres of retail and 3,400 sq metres of leisure, over three plots.

Salford City Council is the local authority that administers planning applications for the MediaCity UK project. The project is located within the Greater Manchester Combined Authority and MIDAS LEP areas, which also sit within the Northern Powerhouse.
